Reference is made to the announcement of the Company dated August 1, 2024 (the “**Announcement**”) in relation to, among other things, the Placing. Capitalized terms used but not otherwise defined herein shall have the same meanings as those defined in the Announcement.

## **COMPLETION OF THE PLACING**

The Board is pleased to announce that completion of the Placing took place on August 8, 2024.

A total of 1,420,000 Placing Shares, representing (i) approximately 1.19% of the H Shares as enlarged by the allotment and issue of the Placing Shares and (ii) approximately 0.34% of the total number of Shares in issue as enlarged by the allotment and issue of the Placing Shares, have been successfully placed at the Placing Price of HK\$92.00 per H Share to no less than six placees. To the best of the Directors’ knowledge, information and belief after having made all reasonable enquiries, (i) each of the placees and their respective ultimate beneficial owners are third parties independent of, and not connected with, the Company and the connected persons of the Company; and (ii) none of the placees has become a substantial shareholder (as defined in the Listing Rules) of the Company immediately after the completion of the Placing.

## **PROCEEDS FROM THE PLACING**

The Company received total net proceeds from the Placing (after deducting all related fees, costs and expenses to be borne or incurred by the Company) of approximately HK\$121.85 million. The net issue price, after deducting such fees, costs and expenses, is therefore approximately HK\$85.81 per Placing Share.

The Company intends to apply the net proceeds from the Placing for the Group’s business operation and development (including, among other things, working capital, general corporate purposes and offshore and onshore investments) and repayment of amounts due (including principal and interests accrued thereon) under the credit facilities granted by the relevant financial institutions to the Group companies. The proceeds will be utilized by the Company and its subsidiaries.
