**POLL RESULTS OF THE 2026 SECOND EXTRAORDINARY
GENERAL MEETING HELD ON MARCH 19, 2026**

References are made to the circular (the “**Circular**”) and the notice of UBTECH ROBOTICS CORP LTD (the “**Company**”) both dated March 4, 2026 in relation to the 2026 second extraordinary general meeting of the Company (“**EGM**”). Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

EGM

The Board is pleased to announce that the EGM was convened and held at JIMU Conference Room, 25/F, Building C1, Nanshan Smart Park, No. 1001 Xueyuan Avenue, Nanshan District, Shenzhen, PRC on Thursday, March 19, 2026.

As at the date of the EGM, the total number of Shares in issue was 503,401,373 Shares, comprising 70,665,977 Domestic Shares and 432,735,396 H Shares, among which the trustee of the H Share incentive scheme adopted by the Company on September 12, 2024, holding 815,950 unvested H Shares, was required to abstain and did abstain from voting on all the resolutions proposed at the EGM. Therefore, as at the date of the EGM, the total number of Shares entitling the holders to attend the EGM and vote for or against the proposed resolution at the meeting is 502,585,423 Shares (including 70,665,977 Domestic Shares and 431,919,446 H Shares).

Save as disclosed above, as at the date of the EGM, (i) none of the Shareholders was required to abstain from voting on any resolution proposed at the EGM pursuant to the Listing Rules; (ii) there were no Shares entitling the Shareholders to attend and abstain from voting in favour of any resolution proposed at the EGM as set out in Rule 13.40 of the Listing Rules; and (iii) none of the Shareholders has stated their intention in the Circular to vote against or to abstain from voting on any resolutions proposed at the EGM.

The Company did not hold any treasury share (including any treasury share deposited with CCASS), or repurchased share pending cancellation.

The H share registrar of the Company, Tricor Investor Services Limited, was appointed as the scrutineer for the purpose of vote-taking at the EGM.

All Directors attended the EGM.
